A Report on "Seminar Programme on Goods & Services Tax"

Date: 29th September, 2017

A Seminar on "Goods & Services Tax" was organsied by BBA and BBA (IB) Dept. 00 26th September, 2017. The objective of the seminar was to make necessary awareness among the students related Goods & Service tax, its reality and future. The seminar was conducted by CA Nilaya Mehta, Nilaya Institute of Pune. This seminar organized under the Programme of "NILAYA MANTHAN" by Nilaya Institute of Pune.

The speaker gave information about Goods & Services Tax (GST), a game changing reform for the Indian economy by creating the Indian economy as one Nation, one Tax and one Market.

Now Goods and Services Tax (GST) is an indirect tax which was introduced in India on 1 July 2017 and was applicable throughout India which replaced multiple cascading taxes levied by the central and state governments such as Entertainment Tax, Value Added Tax (VAT), Excise duties, Import Duties, Luxury Tax, Central Sales Tax, Service Tax and so on.

The speaker informed the students that the GST was introduced as The Constitution Act, 2017. The GST is governed by a GST Council and its Chairman is the Finance Minister of India. Under GST, goods and services are taxed at the following rates, 0%, 5%, 12%, 18% and 28%. There is a special rate of 0.25% on rough precious and semi-precious stones and 3% on gold and other rates on top of 28% GST applies on few items like aerated drinks, huxury cars and tobacco products.

47 students of BBA and BBA-IB actively participated in the said Seminar.

Outcome of the exent: Necessary awareness about GST was created among the students.
